The price of a subscription for those who are not members of the association is as follows: Print: \$44.00 a year (individuals), \$85.00 a year (institutions); Electronic: \$46.00 a year (individuals), \$92.00 a year (institutions); Print and Electronic: \$60.00 a year (individuals); \$125 a year (institutions). Single issues are \$22.00 each (individuals), \$37.50 (institutions). International shipping is \$20.00 a year. Decennial indexes are \$2.00 each for vols. 1–10 and 11–20, \$3.00 each for vols. 21–30 and 31–40, \$7.00 for vols. 41–50, and \$11.00 for all five indexes together, plus postage; all orders must be prepaid.
